Meeting Notes

This open forum was scheduled to allow PHC members an opportunity to discuss and provide input relative to the proposal from Dr. Kraft that we join a cross-regional collaboration.

What services/functions could add value to our work?

[forming a shared services core aka "pit crew"]

- Support that strengthens public health councils throughout our broader region
- Support that deepens our municipal relationships
- Measuring the gaps in our unmet needs (e.g. what services are missing? what is the workforce?)
- Training on evaluation
- Training on coalition capacity building
- A system of care coordination between facilities and communities (recognizing the regional nature of care system)
- Health Data Hub/Advocacy for shared data
- Evaluation and shared measurement
- Deployed evaluation resources (i.e., Don't train me to do this as I don't/won't have time. Come do it for me.)
- Targeting student projects and community service to the things we need help with and priorities we have set
- A regional "test kitchen" to promote and spread innovative thinking
- Resource maps
- Mapping out the funding sources we use and what may be available
- Workforce development
- How can we use this consortium to leverage/develop capacities that benefit all our partners?
- Begin to address affordable housing

Other Comments:

 Recognize the training and technical assistance resources that are already underutilized, such as Center for Excellence (CHI).

What kind of structure would we like to see?

- A coalition of coalitions
- Place to have conversations about the relative value of resources versus their costs
- Tighter integration/alignment of the services that Dartmouth (College and Hitchcock) provide to community
- We have to work from our own existing lists of priorities to select what we work on collectively
- No top-down approach
