- **Caleb Wolfe** is working with the CCBA in Lebanon to develop walking programs. He is looking for ideas about how to take these efforts to scale.
- **Marjorie Matthews** mentioned Peer Support program at Dartmouth-Hitchcock.
- **Jeana Newbern** said that the Lake Sunapee Region VNA is still looking for more survey responses for their Community Health Needs Assessment. She also mentioned the good Day Respite Program at the Lebanon Methodist Church (Fridays, 10 to 3)

They also have a partnership with Upper Valley Aquatic Center to do Aquatics for Arthritis; it is free for older adults. They also offer this program in two other locations.
