NH (Anna Hullinger): Continuing to offer and schedule community-based clinics and location clinics with partners. Looking for more MRC volunteers for fall clinics coming up.

VT (Rudy Fedrizzi): VT cases increasing to about 100+/day now with higher numbers of people hospitalized and in the ICU; contract tracing and testing capacities are ramping back up, meaning some folks are being deployed back to these roles again; hired an epidemiologist (Lyrica Stelle), who will be working specifically on COVID response for the time being.

- Some folks are frustrated that without the Governor's emergency authorization, the State of VT is no longer providing detailed guidance for schools and other settings. Guidance to schools that is out now is brief and offers suggestions. No movement at this point to reinstate emergency authorization.
- VDH is planning for booster distribution when it is authorized, 3rd doses being recommended for people who are immune compromised, and 2-11 year olds.
- VT National Guard is currently running clinics for children ages 12 to 16 and we have recently learned that they will continue in this role through December 2021
- At this point, 85% of Vermonters have at least one dose of vaccine.

9:20 am – West Central Behavioral Health Mobile Crisis Response Team (Roger Osmun)

There are 10 community mental health centers in the state are currently responsible for conducting mobile crisis outreach. In Jan 2022 the statewide crisis line will be active (Beacon). WCBH still receiving calls through our center until the Beacon line goes live.

Anyone experiencing crisis contacts the Beacon state line – many calls can be handled by phone. When they cannot, they dispatch the closest mobile crisis team (WCBH serves our catchment area and sometimes wider).

WCBH creating two office-based teams (Lebanon & Claremont) to successfully meet the goal to arrive at a crisis in the community within the one hour parameter. Two teams gives Beacon the opportunity to have one team deployed and one on standby when needed.

- Previous state model was emergency services (ES) typically responding at ER's to determine next steps in hospitalization and stabilization. Goal is to reduce hospitalizations and over-utilization there. When crises are small and early, they can be mitigated in the community.
- Can serve anyone in the state regardless of residence, wherever they need

- Will take a while to change the culture in the community to get people to use this service and not first responders and ED depts.
- Workforce challenges only half staffed right now as we work to build up the program

9:40 am – Vital Communities Diversity, Equity & Inclusion Projects (Rob Schultz)

Secured funding for a new program to build cohort of non-profit organizations who will come together with their leadership teams to engage in learning around diversity, equity, and inclusion. Training and supporting organizations to develop action plans for long-term work. Creating a community of practice for accountability and shared learning. Selecting 4-6 non-profits, build a cohort for learning, and coordinate action planning. If pilot year goes well, funders would like to see this keep recurring.
