Successful Integration Case Study

Five communities in Virginia share a goal of systems change in early care and education for children prenatal to age 5.

Partners: Stakeholders from hospitals, churches, childcare providers, parents, educators, nonprofits, businesses, educators, government officials

Problem: Data show rates of infant mortality, low birth weight, families living below FPL, childcare access and education, pointing to subpar support for families with young children.



Successful Integration Case Study

Opportunity: Local champions, urgency for change, available resources, and desire to integrate in early care and education system. Concrete goals focused upstream of health outcomes.

Change: Trust and relationships with state agencies, opening up future opportunities. Integration to increase education, awareness, access.
