### Rebecca Desilets – Lebanon Human Services/City of Lebanon

- Lebanon Winter Shelter opened up on January 8
  - Filled to capacity every night
  - o Not opened to children, but service animals can come
  - Located at 160 Mechanic Street
  - Show up at 5 pm for a bed
- Point in Time (PIT) Count
  - Lebanon Human Services and LISTEN are having volunteers in groups of 2 support outreach in the community
  - Outreach would occur on January 22 evening and January 23 morning

# Rudy Fedrizzi – Vermont Department of Health

- Involved in Hope Project, that is hosted by organizations in town of Windsor, and encourages people to put anonymous hope wishes into a chest
  - Hope wishes are shredded and turned into art by a school art class
  - Would love to replicate this in Upper Valley
  - Chest rotates to different public places in community every 2-3 months
  - Public Health Council will pay for the box

# Nancy Kreis - DHMC Population Health

#### Mark Boutwell – Senior Solutions

- Case management services have been shifted to district Area Agencies on Aging, which includes Senior Solutions
  - o If you know someone who is eligible for long-term care and Medicaid, contact Mark
  - Have taken on an additional 130 clients and 5 staff
  - Have seen a low referral rate in Upper Valley, so if you have thoughts to share on why

- Mark would love to talk with different organizations on presentation of services
- Senior Solutions is looking to grow their board if interested, contact Mark
- Senior Solutions will be sending out a 4 5 question survey to solicit input on the needs of older Vermonters for their new 3-year area plan similar to the hospital community needs assessments
  - This plan gets rolled up into a comprehensive state plan that gets submitted to the federal Administration on Community Living

#### Neva Cote - VDH

- Reconvening Upper Valley Oral Health Workgroup
  - Workgroup will be remote and meet quarterly
  - Goal of having another oral pop-up health clinic and focus more broadly on how to be consistently provide access to dental care

### Martha Tecca – Community Care of Lyme and SHARe

- SHARe is supporting a refugee initiative in the Upper Valley
  - People are arriving with different immigration statuses, which requires different services
  - Important to make sure people know their rights as immigrants and rights as folks supporting immigrants
  - Red cards are being printed out from organizations that have information on what immigrants should know, including:
    - You have constitutional rights:
      - DO NOT OPEN THE DOOR if an immigration agent is knocking on the door.
      - DO NOT ANSWER ANY QUESTIONS from an immigration agent if they try to talk to you. You have the right to remain silent.
      - DO NOT SIGN ANYTHING without first speaking to a lawyer. You have the right to speak with a lawyer.
      - If you are outside of your home, ask the agent if you are free to leave and if they say yes, leave calmly.
      - GIVE THIS CARD TO THE AGENT. If you are inside of your home, show the card through the window or slide it under the door.
  - o Martha would love to connect folks supporting immigrants with information

# Michael Redmond – Upper Valley Haven

- "Just Getting By" documentary February 2 at 2 pm at St. Paul's Episcopal Church, next to the Haven
  - o 5 organizations supporting this film, including Upper Valley Haven, CARHE, and LISTEN
  - Speaks to challenges of relying on Public Housing Emergency in VT
  - o Teaches people how to take action at state and federal level
- Haven has recently purchased property with the intention to build a permanent low-barrier shelter of 20 beds and a resource center to connect folks with services
  - Still fundraising for this initiative
  - o Hope to break ground in Spring, with the building available a year later
  - o In response to a question, "low barrier" means that we try to remove any barriers that could prevent someone from accessing the services of the shelter. These include a requirement for sobriety, ID, immigration status, where you're from, having a pet.
